# FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS ("First Amendment") is made this \_\_IZ\_\_ day of \_\_JANUARY\_\_\_\_, 2000, by PULTE LAND DEVELOPMENT CORPORATION, a Michigan corporation, the address of which is 26622 Woodward Avenue, Suite 110, Royal Oak, MI 48067 ("Developer").

#### RECITALS:

- A. In connection with the development of certain real property located in the Township of Plymouth, County of Wayne, State of Michigan, as a residential subdivision known as Country Acres of Plymouth Subdivision No. 4, the plat thereof recorded in Liber 114, Pages 79 through 95, inclusive, Wayne County Records, Developer recorded a certain Declaration Of Covenants, Conditions And Restrictions in Liber 30511, Page 21-41, Wayne County Records (the "Declaration").
- B. In accordance with the provisions of Section 8.1 of the Declaration, Developer desires to amend the Declaration to add Country Acres of Plymouth Subdivision No. 5 as part of the overall Property that is subject to the Declaration.

NOW, THEREFORE, Developer hereby declares that the Declaration is amended as follows:

- Definitions. The following Definitions contained in Article 1 of the Declaration are hereby amended and restated in their entirety as follows:
  - Section 1.11 "Property" shall mean the certain real property described on Exhibit "A" of the Declaration (being Subdivision No. 4), together with the real property described in the Exhibit "A" attached hereto (being Subdivision No.5) and made a part hereof, as the same may be amended.
  - Section 1.17 "Subdivision" shall mean the single family residential subdivisions known as Country Acres of Plymouth Subdivision No. 4 as recorded in Liber 114, Pages 79 through 95, inclusive, Wayne County Records, and Country Acres of Plymouth Subdivision No. 5 as recorded in Liber 115, Pages 41 through 54, inclusive, and any additional phases that may be created pursuant to a recorded plat and added to this Declaration by amendment.
